

1. General provisions of «Social Freezing» social event

- 1.1 The Organizer of the event is the Feskov Human Reproduction Group clinic.
- 1.2 Event objective: This social event is aimed at informing the public about the problem of birth rate reduction in connection with the interest of women in career and development. The social event explains egg cryopreservation as the adequate medical technology for delayed motherhood.
- 1.3 General time of event conducting: 12.09.2019 – 01.05.2020
 - 1.3.1 The said time includes:
 - Duration of informing on of the event and collection of applications for participation: 12.09.2019-15.12.2019
 - Time of processing applications: 01.01.2020-01.02.2020
 - Duration of preparation of candidates for participation in the event: 01.02.2019-01.03.2020
 - Participation: arrival in Ukraine, medical procedures, punctures.
 - Interview with PR team, video interview about the event: 01.03.2020-01.05.2020
- 1.4. The event is divided into 2 periods: the first one is applications submission carried out on the Internet; the second one is proper participation - the cryopreservation procedure is carried out in the of the Feskov Human Reproduction Group clinic.

2. Procedure for conducting the event and participation conditions

- 2.1 The legally capable women from 28 years old to 39 years old can take part in the event.
- 2.2 Gift Fund: the main prize object of the event is a free egg cryopreservation service at the Feskov Human Reproduction Group clinic for 5 years.
- 2.3 The clinic staff cannot participate in the event.
- 2.4 By the fact of participating in the event, you agree and acknowledge that the Organizer of the competition have the right to receive and consider your registration data. The participants agree that their personal data: name, mail address, phone number, email address, photos submitted for participation, etc., can be collected, processed, stored and used to conduct and administer the event.
- 2.5 By the fact of participating in the event, the participant confirms his consent to the photo/ video shooting.

3. Medical data

- 3.1 By the fact of participating in the social project, you confirm your readiness to send to our specialists the necessary medical tests: ultrasound data on small-pelvis organs for the 1st to the 5th days of the menstrual cycle; tests for HIV and hepatitis.
- 3.2 The egg cryopreservation procedure requires a certain level of reproductive system health.
- 3.3 To carry out the cryopreservation procedure, it is necessary to stimulate the ovaries with the help of medications.
- 3.4 The egg puncture is performed on the day of ovulation.
- 3.5 In case of successful freezing of healthy eggs, they will be stored in the cryobank of the Feskov Human Reproduction Group clinic (Ukraine, Kharkiv) for 5 years.

4. Financial information

- 4.1 The social project provides for the free provision of medical services for 5 women chosen by us.
- 4.2 The primary online consultation of the fertility specialist, coordination of the trip to Ukraine by the manager, all the necessary medical procedures and medications to be used to prepare for the puncture, the puncture procedure are free for 5 selected participating women.
- 4.3 The accommodation at the hotel during your stay in Ukraine and meals are also paid by the Feskov Human Reproduction Group clinic.
- 4.4 The participant pays only the transportation costs that are necessary for arrival in Kharkov (Ukraine).

5. Documents

- 5.1 The five selected women shall sign an agreement on the provision of medical services and give their consent for taking photos and shooting videos: photographing for the clinic's social networks, shooting video interviews.
